1. INDICTABLE OFFENSES;
2. OPERATING A VEHICLE WHILE UNDER THE INFLUENCE OF ALCOHOL OR ANY DRUG OF ABUSE.
3. LEAVING THE SCENE OF ACCIDENT.
4. DRIVING WHILE UNDER SUSPENSION OR REVOCATION OF DRIVER'S LICENSE.
5. DRIVING WITHOUT BEING LICENSED TO DRIVE.
6. A THIRD MOVING VIOLATION OFFENSE WITHIN A TWELVE-MONTH PERIOD.
7. FAILURE TO STOP AND REMAIN STANDING UPON MEETING OR OVERTAKING A SCHOOL BUS STOPPED ON THE HIGHWAY FOR THE PURPOSE OF RECEIVING OR DISCHARGING A SCHOOL CHILD.
8. WILLFULLY ELUDING OR FLEEING A POLICE OFFICER.
9. DRAG RACING.
10. WILFUL WANTON DISREGARD FOR SAFETY
